

# How to Remove a Guest from an MSC Cruise Reservation (Complete Guide)

To remove a guest +1 877 654 9271 US/CANADA OR +44 800 054 8541 (UK) from an MSC Cruise reservation, travelers usually need to contact MSC support because this change is rarely available through the online booking portal. Guest removal requests are typically handled by customer representatives who review booking details +1 877 654 9271 US/CANADA OR +52 800 351 0319 (Mexico) and explain possible changes to the reservation. In many situations the support team can confirm if the request can be processed before the sailing date +1 877 654 9271 US/CANADA OR +61 180 095 6584 (AUS).

## **Replacing a Guest Instead of Removing Them**

## Original Guest Requirement
